The minimum reimbursement is \$100 which can be divided among different family members. A separate HRA claim reimbursement form must be submitted for each individual family member. HRA claim reimbursement forms are available online at www.ibew164.org.

Submit your claim for reimbursement within 12 months of the date you incurred the expense. Do not submit a claim form totaling less than \$20. You will not be reimbursed for an amount greater than what is in your HRA account at the time you submit your claim. The Plan will directly reimburse you.
