An ISDA Master Agreement consists of the preprinted form master agreement and a Schedule that contains the relevant credit terms and any additional provisions negotiated between the parties. It also may include a credit support document, such as the New York law governed, security interest-based ISDA Credit Support Annex.

Termination Rights and Valuation- The ISDA Master Agreement includes Events of Default and Termination Events that allow one or both parties (depending on the event) to terminate the agreement and outstanding transactions, generally with the payment by one party of the net value of the transactions being terminated.
